Assuming you file on time, you must keep records of all information used to complete your self-assessment tax returns for 22 months after the end of the tax year the return is for. A penalty of up to £3,000 can apply for each failure to keep or preserve adequate records.

The deadline for filing the 2017/18 self-assessment tax return of 31 January 2019 has now passed. You filed your return on time and paid the tax that you thought was due, but you know realise that you have made a mistake. Is it too late to correct it, and if not, how do you go about it?

The SA100 is the main tax return for individuals. Use it to file your tax return for: income and capital gains. student loan repayments. interest. pensions. annuities. charitable giving. claiming tax reliefs and allowances.

### Self Assessment tax returns: Deadlines - GOV.UK

If you have never submitted a self-assessment tax return before, you must register to do so by 5 October 2019 in order to submit for the 2018-19 tax year. 31 October 2019: paper tax returns due. This is the deadline for filing a paper tax return. However, if you receive notice from HMRC that you must file a tax return after 31 July 2019, you'll need to send back the completed form within three months of the date of issue on the notice.

### Can you amend your self assessment tax return once it has ...

You can also fill in a Self Assessment tax return if you want to make voluntary Class 2 National Insurance Contributions (NICs) to help you qualify for benefits such as the State Pension. You do not need to fill in a Self Assessment tax return if you're an employee who has paid tax through the Pay As You Earn (PAYE) system, unless you earned over £100,000.

### Tax return for Self Assessment - GOV.UK

These people need to report these earnings on a self-assessment tax return. A self-assessment tax return form is a summary of everything a person has earned during one complete tax year. It also includes a tax calculation, so that HMRC know how much tax and national insurance needs to be paid to them. A tax year runs from 6 April to 5 April.

### HMRC: Paper self-assessment tax return deadline is today ...

While you'll need to send paper tax returns in by next week, the deadline for paying your tax bill is 31 January 2019. As well as any 2017/18 tax owing, most self-assessment payers must also pay the first half of what's called a 'payment on account' for the 2018/19 tax year.
